- Purpose & Objectives –

- b) Jaleswar College, Tapoban, Jaleswar, Goalpara and Dalgoma Anchalik College, Dalgoma, Goalpara will jointly organize Seminars, Workshops, Conferences, Symposiums & Competitions from time to time.
- c) Apart from the aforesaid linkage Jaleswar College, Tapoban, Jaleswar, Goalpara and Dalgoma Anchalik College, Dalgoma, Goalpara will collaborate to organize extension and outreach activities like socio-economic & welfare initiatives for neighbouring & rural communities.

e) Jaleswar College, Tapoban, Jaleswar, Goalpara and Dalgoma Anchalik College, Dalgoma, Goalpara will also work for peace, brotherhood, national integrity and communal harmony.

This MoU is valid for a period of three years from the date of signing of the MoU and can be extended for a period of two years on the recommendation of a review committee.

The MoU will automatically lapse after three years, unless renewed.

By and between:

And

Principal, Jaleswar College, Tapoban, Goalpara, Assam (Party-II)

Party-I and Party-II agree by this MoU to work hereafter for the Quality Enhancement in

- 5) Both the parties are agreed to publish Books and Journals Jointly. In this regard both the parties will share the expenditure at 50:50 ratio.
- 6) Both the parties are agreed to take up community developmental work. In this regard expenditure incurred will be shared by both at 50:50 ratio
- 7) Both the parties agreed to share library resources of for greater interest of the students and faculties either of the parties.
- 8) The Validity of this MoU will remain till the withdrawal of the MoU by either of the parties.

THIS MEMORANDUM OF UNDERSTANDING WITNESS AS FOLLOWS:

1. That to organize orientation lectures for overall development of students and teachers.
2. That to organize Faculty Development Programmes in collaborative mode.
3. That to share knowledge, information and resources and creating opportunities for collaboration in research works.
4. That to undertake students exchange programmes for academic purposes.
5. That to offer faculty exchange programmes for a stipulated period for academic purposes.
6. That to undertake students' internships based on academic requirements.
7. That to publish research books, book chapters, general publication media and other academic journals in collaborative mode between the teachers.
8. That to use mutual learning environment as a platform for providing information and communication technology.
9. That the students will be made to comply with the policies of both the institutions.
10. That to utilise the library resources of both the colleges by students and teachers.
11. That to organize extension education programmes in collaborative mode for the benefits of the students.
12. The MoU will be valid for a period of 3 years before renewal.

13. **Termination:** Either party may terminate this MoU by providing written termination notice of its intention to terminate the MoU to the other party.
14. **Modification:** The parties may change or modify the terms of this agreement only by written amendment signed by both the parties.
15. **Settlement of disputes:** Any disputes concerning interpretation and application of this MoU shall be settled amicably through consultation or negotiation between the parties.
